Acquisition of 45.09% of Phnom Penh SEZ Plc. stocks Has Been Officially Carried Out Today at the Cambodia Securities Exchange

Today, an acquisition of 45.09% of Phnom Penh SEZ Plc.'s stock, with the stock symbol PPSP, worth KHR 68,385,100,000 or equivalent to USD 16,765,163.03 has been officially carried out at the Cambodia Securities Exchange via Negotiated Trading Method (NTM), and was intermediated by the SBI Royal Securities as the broker. The price and other details of the trade were negotiated outside the market between a local individual seller and a local institutional buyer; the trade is officially executed and recognized at the Cambodia Securities Exchange today.

To recall, NTM is a trading method allowing a pair of investors to place and execute their confidential orders in a single large transaction after successful negotiation on the transaction conditions. This trading method has been officially implemented in 2018 for both the stock market and the bond market. Since the launch, there have been 24 trades executed using the NTM in the stock market.
